Key achievements: **launching of the CCBA report** under the patronage of the Ministry of Child Development and Women's Affairs and in collaboration with the Office of the Adviser on Reconciliation to His Excellency the President; establishment of the **first parliamentary Children's Caucus in Sri Lanka**; the formation of a **regional working group on the CCBA/BfC in Asia** led by Sri Lanka and Pakistan, also comprised of Bangladesh, Nepal and Philippines; being included as a **'best practice' in the global toolkit on following up on Concluding Observations of the UNCRC Committee**, compiled by Child Rights Connect.
